### **Privacy Notice**

Pink Programming provides this Privacy Notice to inform you about the personal data we collect, the purposes for which we collect and process it, and how we handle your information. ### **Cookie Notice**

Our website uses cookies to enhance your browsing experience. The Cookie Notice includes three layers: essential, statistical, and marketing. Essential cookies are necessary for the website to function, and they are always enabled. The other two, statistical and marketing cookies, are optional, and you can choose whether to enable them.

**Information Related to Site Usage:** We collect and retain information related to site usage, such as pages visited, clicks, order of page visits, and URLs linking to Pink Programming. To gather this data, we may log IP addresses, Internet Service Providers, operating systems, geographic locations, and browser software. We may also use cookies when you visit our site. This information helps us improve site quality, provide better services based on statistics and user behavior, and enhance security.

**Personally Identifiable Information:** This information, used to identify you, may be collected when you create a user profile, contact us with inquiries, subscribe to our newsletter, purchase services, participate in workshops, engage on our social media platforms, or take surveys. It may include your name, nationality, current city of residence, picture, social profile URLs, and email address. Pink Programming may use this information to respond to inquiries, provide specific services, send updates, conduct research, provide technical support, verify user identity, and communicate with users.
